1. Regulatory Techniques to lower costs and barriers

- Directly: EU rules to **ease cross-border** digital trade
 - Country-of-origin principle
 - Prohibition of nationality/residence discrimination or surcharges
- Indirectly: EU **harmonisation of national rules**
 - EU rules, Codes of conduct, standards
 - 50 shades of harmonisation
- **National enforcement agencies**
 - Minimum EU requirements on structure
 - Effective sanctions
- **Coordination** of national enforcement
 - From information exchange to joint actions, possibly within EU networks
 - Common interpretation procedures

Other EU techniques to reduce national divergences

- **Strategies and Action Plans**
- **Monitoring** and reporting
- **Financing**
 - EU Programmes: ESFI, EFSI, CEF, H2020 ...
 - PPPs
 - Joint national actions

2. Actions during the 8th Parliamentary legislature

- Lots has been achieved
- Mainly with **rules**
 - Specific for key cross-border issues
 - Harmonisation of national laws mainly with EU Regulations (19 - 63%) and Commission interpretative Guidance (9)
 - Strengthening of national agencies and their cooperation
 - Reliance on EU Codes of conducts and standards
- Complemented by **non-regulatory** actions
 - Many Action Plans - Close EU Monitoring (e.g. DESI)
 - Increase use of EU Funds

E-Commerce-Content-Platforms

- Internal market clause
- Some specific rules to support cross-border trade: geo-blocking, portability, VAT, parcel delivery
- Increased harmonization of rules for operations of platforms: transparency, illegal content
- Increase cooperation: ERGA
- Facilitate dispute resolution

E-Government

- Action plan to stimulate e-gov and interoperability
- Single Digital Gateway by 2020
- Some EU financial support

Intellectual Property

- Copyright exemption for research
- Special formats for print-disabled
- Increased obligations on online providers and new rights for publishers and content holders

Data and AI

- Facilitate a fifth freedom: data
- Partial harmonization of national rules on personal or public data
- Extensive cooperation between DPAs and DPB to ensure consistent enforcement
- Financial support for costly data infrastructures: Cloud, €1 bn for supercomputer
- European AI alliance & High-Level Expert Group

Consumer Protection

- Adapted harmonised rules to digital, esp. transparency and unfair practices
- Strengthened cooperation between NCA within CPC Network

Security and Trust

- Emerging harmonisation
- New cooperations: CSIRTs, ENISA
- Some financial support

Electronic communications Networks and Services

- Specific rules on key cross-border issues: international roaming, calls
- Partial harmonization of national rules to ease entry and spectrum use and stimulate private investments while protecting consumers
- Maintain cooperation between NRAs within BEREC
- More EU financial support for deployment of new infrastructures: €29 bn from EFSI and €14 bn from ESIF

3. Possible Future Actions

- Fields of action
 - Content and Copyright
 - What industry structure do we want/need?
 - E-Government
 - National and cross-border digital public services
 - Regulating *with* digital technologies
 - Data, the infrastructure for innovation
 - Fluidity of data within and across Member States
 - AI and EU industrial policy
 - Not only rules but comprehensive sets of policies to affirm EU digital sovereignty

Possible Future Actions

- Techniques
 - Regulatory
 - Country of origin principle is key but requires mutual trust
 - Simplification and more horizontal and principled-based EU legislation
 - More EU-type enforcement: establishment of EU like Federal Trade Commission with national bureaus
 - Complemented by non-regulatory
 - Monitoring and exchange of best practices
 - Develop digital skills
 - Increasing smart use of EU funds for cross-border projects
