

## Senior Manager Tech, Media & Telecoms (TMT)

Reporting to the Director General, our new colleague will:

This includes research projects, policy papers, events, and other types of activities that bring independent and incisive policy recommendations to shape on-going debates and help set the future agenda.
- Identify and recruit new corporate and regulatory members to support and participate in CERRE's work.
- Help deliver value to our members by meeting their needs while maintaining the strict independence of our research work.
- Working with the communications team, strengthen CERRE's position, broaden our outreach with policymakers and other corporate and civil society stakeholders to further enhance our influence in policymaking and regulation.
- Play an active role within CERRE's leadership team and help advance CERRE's overall strategy and activities.

The ideal candidate:

- Has more than 7 years' experience in growing service organisations and/or business units.
- Is quick off the mark and possesses good knowledge of the European policy process, its key players, and the topics driving the tech, media, and telecom agenda. Knowledge of mobility and/or sustainability issues is a plus.
- Can demonstrate a track record of outstanding results, securing project funding, membership development, and financial support from institutions (e.g., foundations, EU, etc.).
- Is an excellent communicator, equally at ease - in written and spoken English - with senior executives from our members, with policymakers of all levels and with our academic team.
- Has and will further develop an impressive personal network of contacts within industry, regulatory authorities, the EU institutions, and other relevant stakeholders.
- Is an *entrepreneur* - ready to launch new initiatives and activities for their own practices but also beyond (i.e., in collaboration with colleagues working on energy & sustainability).
- Is a natural, positive, and proactive team player who will be an enthusiastic colleague in

a small, agile team; will be setting high standards for their own work, helping others meet their objectives, and focused on finding solutions to complex issues.

- Has a permanent right to work in the EU.

The position is based in Brussels (Avenue Louise / Bois de la Cambre) and a very competitive package is on offer to the right candidate, who is ideally able to start as soon as possible.
